INVITATION TO BID REPAINTING OF ROOFING, EXTERIOR WALL AND VARIOUS REPAIR OF MIXED-USED BUILDING

1. The Tarlac State University through **Special Budget** intends to apply the sum of **Two Million One Hundred Eight Thousand Three Hundred Seven Pesos and 78/100 (Php 2,108,307.78)** being the Approved Budget for the Contract (ABC) to payment of the project: **Repainting of Roofing, Exterior Wall and Various Repair of Mixed-Used Building**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Tarlac State University now invites **contractors registered with PhilGEPS** and have a **valid Philippine Contractors Accreditation Board (PCAB) license of at least Size Range Small B, Category C & D** to apply for the **Repainting of Roofing, Exterior Wall and Various Repair of Mixed-Used Building**. Completion of the work is required within **One Hundred Twenty (120) Calendar Days** from receipt of the Notice to Proceed.

Bidders should have completed within five (5) years from the date of submission and receipt of bids a contract similar to the Project, with at least 50% of the cost of the ABC.

3. Bidding will be conducted through open competitive bidding procedures using discretionary "pass/fail" criterion as specified in the Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorship, partnership, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of the country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
